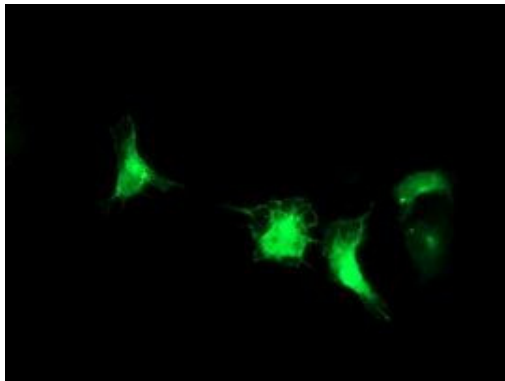

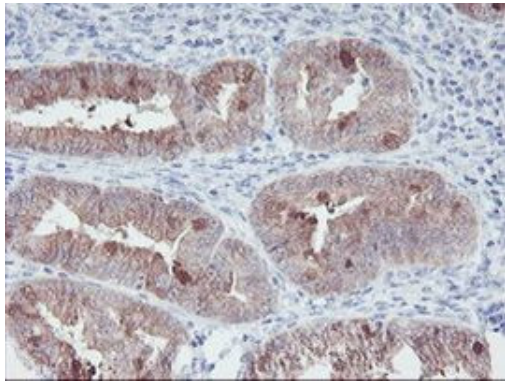

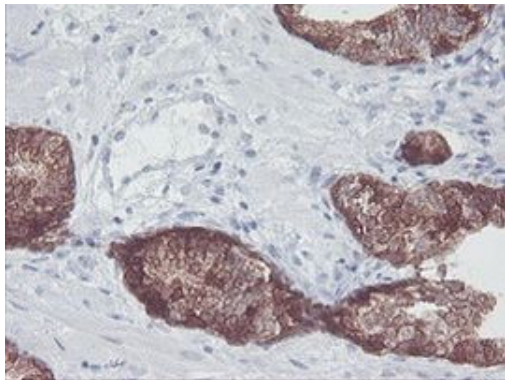
IRF6 Antibody (MA5-25609) in ICC/IF

Immunofluorescent analysis of IRF6 in COS7 cells. Cells were transfected with a plasmid overexpressing IRF6 and probed with a IRF6 monoclonal antibody (Product # MA5-25609).



IRF6 Antibody (MA5-25609) in IHC (P)

Immunohistochemistry was performed on paraffin-embedded adenocarcinoma of human endometrium tissue. To expose target proteins, 10mM citric buffer, pH6.0, 100°C for 10min was used. Following antigen retrieval, tissues were probed with a IRF6 monoclonal antibody (Product # MA5-25609).

Immunohistochemistry was performed on paraffin-embedded carcinoma of human prostate tissue. To expose target proteins, 10mM citric buffer, pH6.0, 100°C for 10min was used. Following antigen retrieval, tissues were probed with a IRF6 monoclonal antibody (Product # MA5-25609).
