




TRBP Antibody (MA5-38184) in WB

Western blot was performed using Anti-TRBP Recombinant Rabbit Monoclonal Antibody (ARC1792) (Product # MA5-38184) and a 39 kDa band corresponding to TAR RNA-binding protein 2; TARBP2; was observed across the cell panel tested. Whole cell extracts (30 µg lysate) of MCF7 (Lane 1), MCF 10A (Lane 2), SK-BR-3 (Lane 3), A549 (Lane 4), Hep G2 (Lane 5) and HEK-293 (Lane 6) were electrophoresed using NuPAGETM 4-12% Bis-Tris Protein Gel (Product # NP0322BOX), 12 well. Resolved proteins were then transferred onto a nitrocellulose membrane (Product # IB23001) by iBlot® 2 Dry Blotting System (Product # IB21001). The blot was probed with the primary antibody (1:1000 dilution) and detected by chemiluminescence with Goat anti-Rabbit IgG (Heavy Chain) SuperclonalTM Recombinant Secondary Antibody, HRP (Product # A27036, 1:20,000 dilution) using the iBrightTM FL1500 Imaging System (Product # A44115). Chemiluminescent detection was performed using SuperSignalTM West Dura Extended Duration Substrate (Product # 34076).

Antibody specificity was demonstrated by siRNA mediated knockdown of target protein. MCF7 cells were transfected with TAR RNA-binding protein 2; TARBP2 siRNA and decrease in signal intensity was observed in Western Blot application using Anti-TRBP Recombinant Rabbit Monoclonal Antibody (ARC1792) (Product # MA5-38184). {KD}
