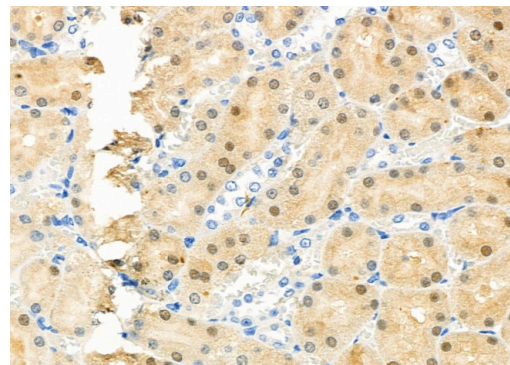

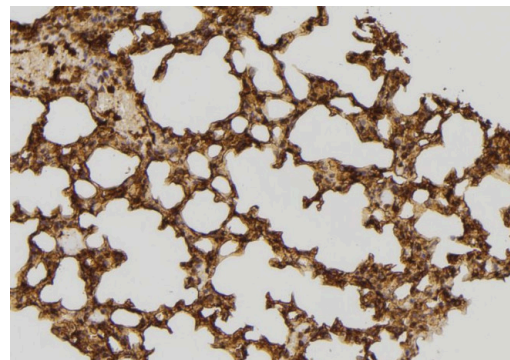

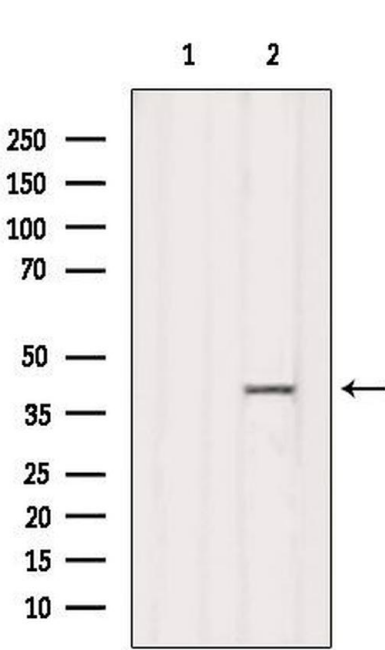
**RFC4 Antibody (PA5-102786) in IHC (P)**

Immunohistochemistry analysis of RFC4 in human gastric cancer. The sample was formaldehyde fixed and a heat mediated antigen retrieval step in citrate buffer was performed. Samples were incubated with RFC4 polyclonal antibody (Product # PA5-102786) using a dilution of 1:100 (4°C overnight) followed by HRP conjugated anti-Rabbit secondary antibody.



**RFC4 Antibody (PA5-102786) in IHC (P)**

Immunohistochemistry analysis of paraffin-embedded RFC4 in mouse lung tissue. Antigen retrieval was performed using citrate buffer. Samples were blocked with blocking buffer (1.5 hr, 22°C), incubated with RFC4 polyclonal antibody (Product # PA5-102786) using a dilution of 1:100 (1.5 hr, 22°C), followed by HRP conjugated goat anti-rabbit.

Western blot analysis of RFC4 in COS7 cell lysate (left lane: treated with blocking peptide). Samples were incubated with RFC4 polyclonal antibody (Product # PA5-102786).
