




#### PLSCR1 Antibody (PA5-119773) in ICC/IF

Immunocytochemistry-Immunofluorescence analysis of of Scramblase 1 in HUVEC cells (green). Formalin fixed cells were permeabilized with 0.1% Triton X-100 in TBS for 10 minutes at room temperature and blocked with 1% Blocker BSA for 15 minutes at room temperature. Cells were probed with PLSCR1 Polyclonal Antibody (Product # PA5-119773) at a dilution of 1:50 for 1 hour at room temperature, washed with PBS. Alexa Fluor 488 Goat anti-Rabbit IgG was used as the secondary antibody at 1:1,000 dilution. The nuclear counter stain is DAPI (blue).



### PLSCR1 Antibody (PA5-119773) in IHC (P)

Immunohistochemistry (Paraffin) analysis of paraffin-embedded human tonsil tissue using PLSCR1 Polyclonal Antibody (Product # PA5-119773). The section was pre-treated using heat mediated antigen retrieval with sodium citrate buffer (pH 6.0) for 20 minutes. The tissues were blocked in 5% BSA for 30 minutes at room temperature, washed with ddH2O and PBS, and then probed with the PLSCR1 antibody at a dilution of 1:200 for 30 minutes at room temperature. The detection was performed using an HRP conjugated compact polymer system. DAB was used as the chromogen. Tissues were counterstained with hematoxylin and mounted with DPX.



## PLSCR1 Antibody (PA5-119773) in WB

Western blot analysis of Scramblase 1 on 293 cell lysates. Proteins were transferred to a PVDF membrane and blocked with 5% BSA in PBS for 1 hour at room temperature. PLSCR1 Polyclonal Antibody (Product # PA5-119773) at 1: 500 was used in 5% BSA at room temperature for 2 hours. Goat Anti-Rabbit IgG - HRP Secondary Antibody at 1:5,000 dilution was used for 1 hour at room temperature.
