

Predicted reactivity: Mouse (80%), Rat (82%), Rhesus Monkey (98%), Bovine (88%).


Store product as a concentrated solution. Centrifuge briefly prior to opening the vial.


#### TdT Antibody (PA5-28880)

Antibody specificity was demonstrated by detection of differential basal expression of the target in cell lines owing to their inherent genetic constitution. Differential basal expression of TdT was observed across the cell lines tested using product (Product # PA5-28880) in western blot. {RE}



### TdT Antibody (PA5-28880) in WB

Western blot analysis was performed on Whole cell extracts (30 µg lysate) of MOLT-4 (Lane 1), A431 (Lane 2), EB2 (Lane 3) Ramos (Lane 4), Jurkat (Lane 5) and Raji (Lane 6). The blot was probed with Anti-TdT Polyclonal Antibody (Product # PA5-28880, 1:1000 dilution) and detected by chemiluminescence using Goat anti-Rabbit IgG (Heavy Chain) Superclonal™ Secondary Antibody, HRP conjugate (Product # A27036, 0.25 µg/mL, 1:4000 dilution). A 58.5 kDa band corresponding to TdT was observed across the cell lines positive for TdT (Lanes 1 and 5), while this band was absent in cell lines which are reported negative for TdT expression (Lanes 2-4, 6).

TdT Polyclonal Antibody detects TdT protein by western blot analysis. A. 30 μg 293T whole cell extract. B. 30 μg whole cell extract of human DNTT-transfected 293T cells.7.5 % SDS-PAGE. TdT Polyclonal Antibody (Product # PA5-28880) dilution: 1:5,000.
