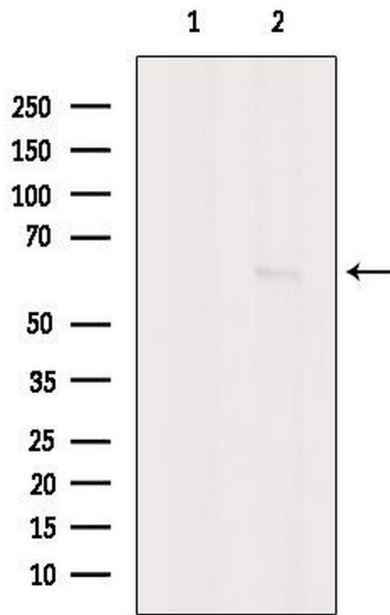

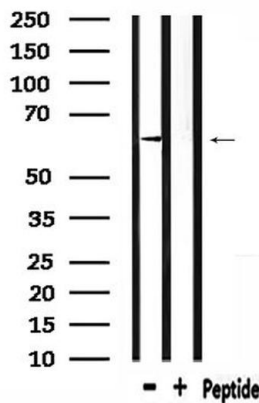
CaMKII beta/gamma Antibody (PA5-99600) in WB
