

#### **Product Specific Information**


Heat-mediated antigen retrieval is recommended prior to staining, using a 10mM citrate buffer, pH 6.0, for 10 minutes followed by cooling at room temperature for 20 min. Following antigen retrieval, incubate samples with primary antibody for 30 min at room temperature. A suggested positive control is placenta or liver carcinoma.


#### Glypican 3 Antibody (MA5-16368) in WB

Western blot was performed using anti-Glypican 3 Monoclonal Antibody (SP86) (Product # MA5-16368) and a 66 kDa band corresponding to GPC3 was observed in Hep G2 and not in HeLa, MCF7 and T-47D which are reported to be negative. Membrane enriched extracts (30 µg lysate) of Hep G2 (Lane 1), HeLa (Lane 2), MCF7 (Lane 3) and T-47D (Lane 4) were electrophoresed using NuPAGE<sup>TM</sup> 10% Bis-Tris Protein Gel (Product # NP0302BOX). Resolved proteins were then transferred onto a nitrocellulose membrane (Product # IB23001) by iBlot® 2 Dry Blotting System (Product # IB21001). The blot was probed with the primary antibody (1:1000 dilution) and detected by chemiluminescence with Goat anti-Rabbit IgG (Heavy Chain) Superclonal<sup>TM</sup> Recombinant Secondary Antibody, HRP (Product # A27036, 1:4000 dilution) using the iBright FL 1000 (Product # A32752). Chemiluminescent detection was performed using SuperSignal<sup>TM</sup> West Dura Extended Duration Substrate (Product # 34076).



## Glypican 3 Antibody (MA5-16368)

Antibody specificity was demonstrated by detection of differential basal expression of the target across cell models tested owing to their inherent genetic constitution. Relative expression of GPC3 was observed in Hep G2 in comparison to HeLa, MCF7 and T-47D using Glypican 3 Monoclonal Antibody (SP86) (Product # MA5-16368) in Western Blot. {RE}
