




RAD51B Antibody (MA5-25683) in WB

Western blot analysis of RAD51L1 in SVT2, PC12 cells using 10 μ g per lane. Samples were probed with RAD51L1 (Product # MA5-25683) monoclonal antibody at a dilution of 1:200.

Immunofluorescent analysis of RAD51L1 in COS7 cells. Cells were transfected with a plasmid overexpressing RAD51L1 and probed with a RAD51L1 monoclonal antibody (Product # MA5-25683).
