





## Chromogranin A Antibody (MA5-35965) in WB

Western Blot analysis of Chromogranin A using Chromogranin A Recombinant Monoclonal Antibody (Product # MA5-35965) at a dilution of 1:500. Lane A: HepG2 whole cell lysate, Lane B: SH-SY5Y whole cell lysate, (Lysates/proteins at 30  $\mu g$  per lane). The secondary antibody used was a Goat Anti-Rabbit IgG H&L (Dylight800) at 1:10,000 dilution. Developed using the Odyssey technique and performed under reducing conditions. Predicted band size: 50 kDa. Observed band size: 50 kDa.



## Chromogranin A Antibody (MA5-35965) in ICC/IF

Immunocytochemistry-Immunofluorescence analysis of Chromogranin A in HepG2 cells. Cells were fixed with 4% PFA, permeabilized with 0.1% Triton X-100 in PBS, blocked with 10% serum, and incubated with Chromogranin A Recombinant Monoclonal Antibody (Product # MA5-35965) (1:60) at 4°C overnight. Then cells were stained with the Alexa Fluor 594-conjugated Goat Antirabbit IgG secondary antibody (red) and counterstained with DAPI (blue). Positive staining was localized to Cytoplasm.
