




### ATP1A2 Antibody (PA5-101902) in IHC (P)

Samples were incubated with ATP1A2 polyclonal antibody (Product # PA5-101902) using a dilution of 1:100 (4° C overnight) followed by HRP conjugated anti-Rabbit secondary antibody.
