




MNT Antibody (PA5-101990) in IHC (P)

Immunohistochemistry analysis of MNT in rat testis tissue. The sample was formaldehyde fixed and a heat mediated antigen retrieval step in citrate buffer was performed. Samples were incubated with MNT polyclonal antibody (Product # PA5-101990) using a dilution of 1:100 (4°C overnight) followed by HRP conjugated anti-Rabbit secondary antibody.

Western blot analysis of MNT extracts from COLO205 cells (heat-shock treatment). Samples were incubated with MNT polyclonal antibody (Product # PA5-101990) using a dilution of 1:1,000. Observed bands: 70 kDa.

Western blot analysis of MNT in A549 cell lysate (left lane: treated with the antigen-specific peptide). Samples were incubated with MNT polyclonal antibody (Product # PA5-101990).
