





2-hydroxyisobutyryl-Histone H2B (Lys108) Antibody (PA5-112474) in WB Western Blot analysis of 2-hydroxyisobutyryl-Histone H2B (Lys108) in multiple sample types using a 2-hydroxyisobutyryl-Histone H2B (Lys108) polyclonal antibody (Product # PA5-112474) at a dilution of 1:300. A goat anti rabbit polyclonal secondary antibody was used at a dilution of 1:50,000. Sample types that were tested include: K562 whole cell lysate, HepG2 whole cell lysate, 293 whole cell lysate; Untreated (-) or treated (+) with 30mM sodium butyrate for 4h.



2-hydroxyisobutyryl-Histone H2B (Lys108) Antibody (PA5-112474) in ICC/IF Immunocytochemichal analysis of 2-hydroxyisobutyryl-Histone H2B (Lys108) in Hela cells using a Polyclonal antibody (Product # PA5-112474) at a dilution of 1: 15. The cells were fixed in 4% formaldehyde, permeabilized using 0.2% Triton X-100 and blocked in 10% normal Goat Serum. The cells were then incubated with the antibody overnight at 4°C. The secondary antibody was Alexa Fluor 488-congugated Goat Anti-Rabbit IgG(H+L). Cells were also counter-stained with DAPI.
