





Western Blot analysis of Serglycin in multiple sample types using a Serglycin polyclonal antibody (Product # PA5-112724) at a concentration of 9 μ g/ml. A goat anti rabbit polyclonal secondary antibody was used at a dilution of 1:10,000. Sample types that were tested include: Lane 1: THP-1 whole cell lysate, Lane 2: HL60 whole cell lysate.
