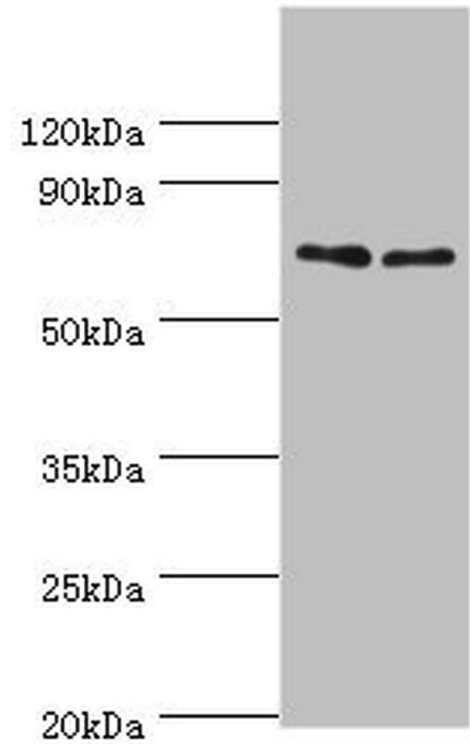

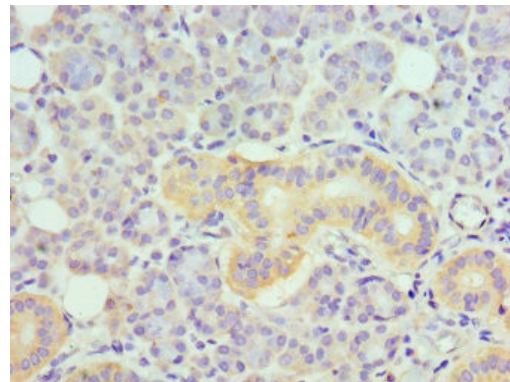
DR6 Antibody (PA5-112766) in WB

Western Blot analysis of DR6 in multiple sample types using a DR6 polyclonal antibody (Product # PA5-112766) at a concentration of 4 µg/ml. A goat anti rabbit polyclonal secondary antibody was used at a dilution of 1:10,000. Sample types that were tested include: Lane 1: K562 whole cell lysate, Lane 2: Jurkat whole cell lysate.
