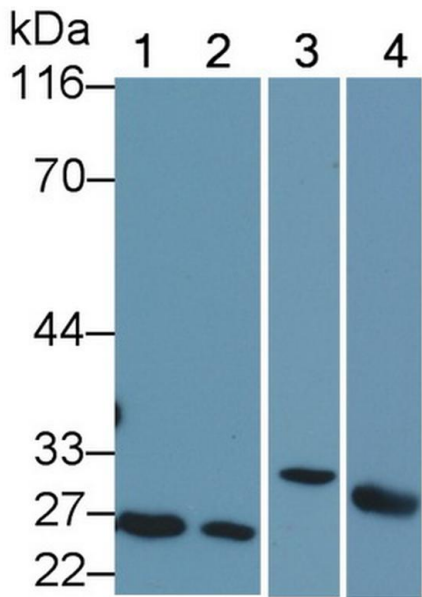

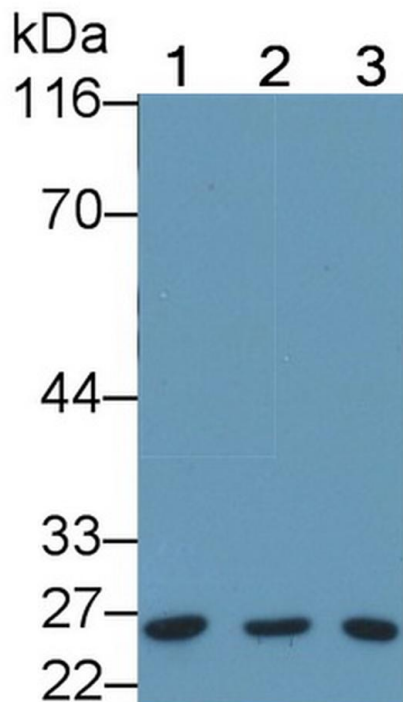

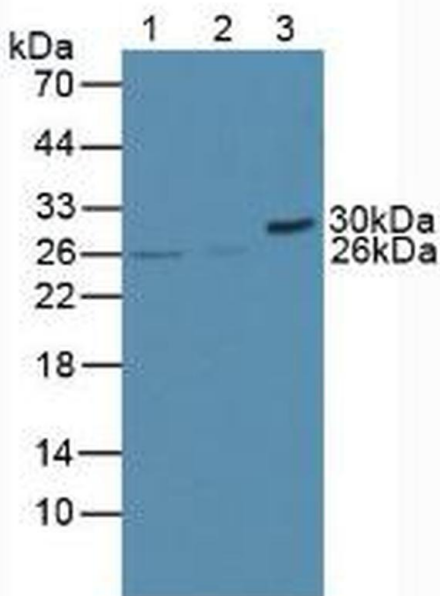


Bcl-2 Antibody (PA5-118976) in WB
