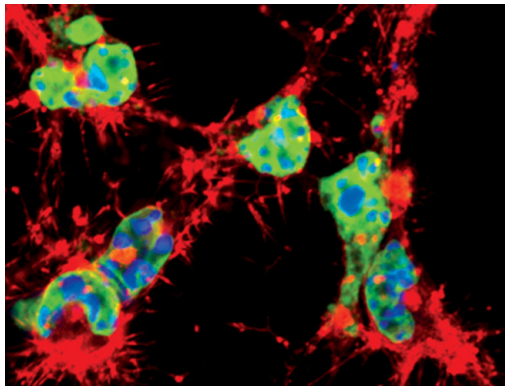

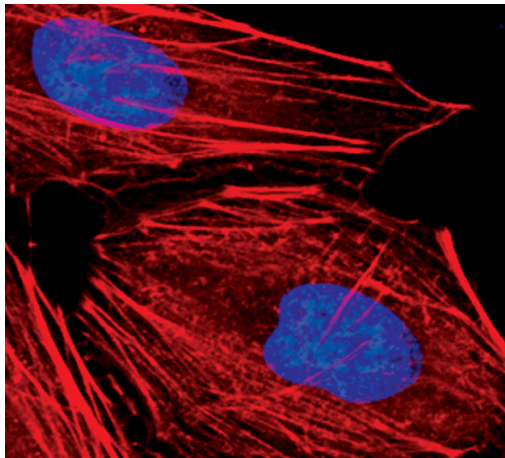
It is not recommended to aliquot this antibody.

This antibody is not cross-reactive with full length lamin A or lamin C.

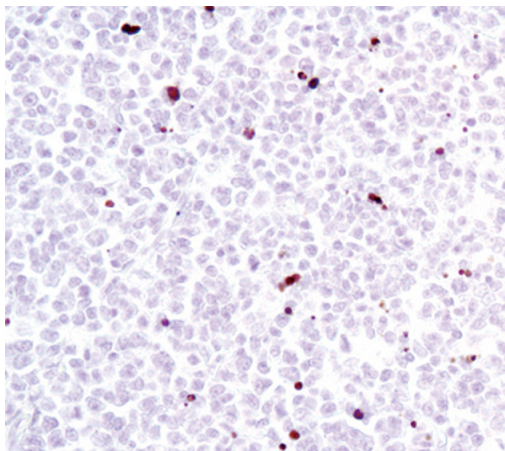
