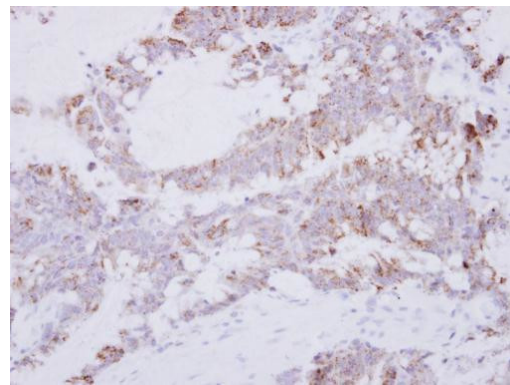

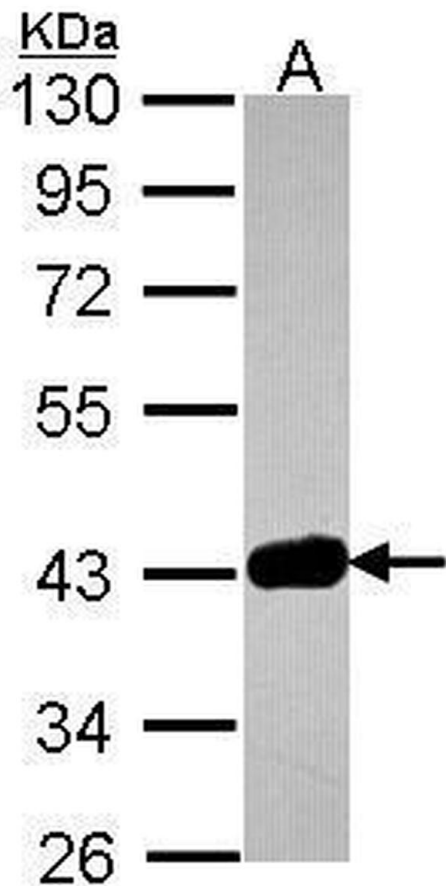
Predicted reactivity: Mouse (90%), Rat (92%), Rhesus Monkey (99%), Bovine (90%).
