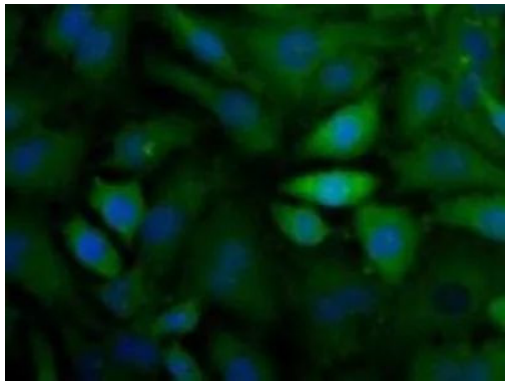

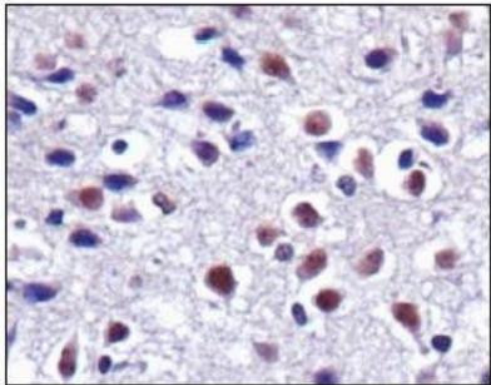

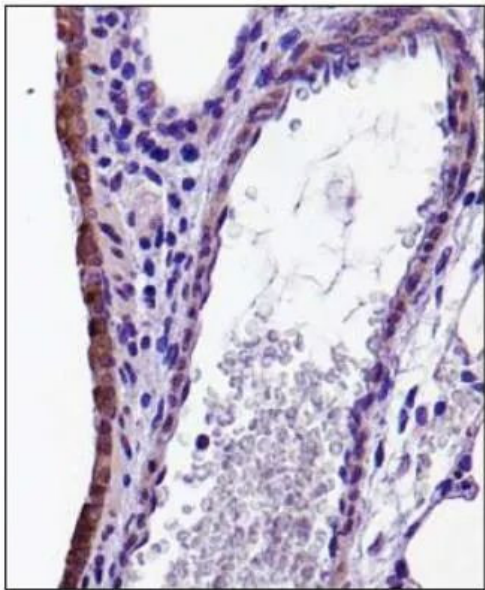
CX3CL1 Antibody (PA5-23062) in ICC/IF
