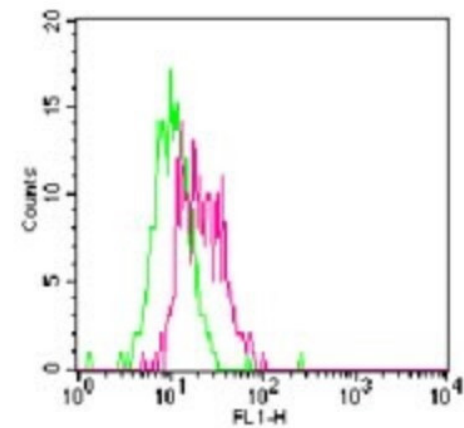

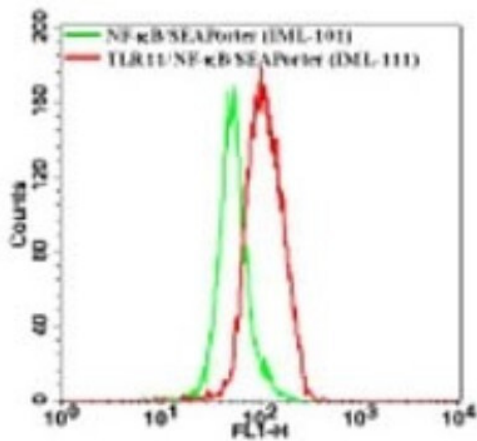
TLR11 Antibody (PA5-23103) in Flow
