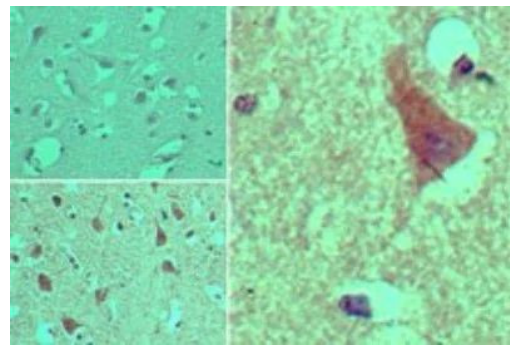

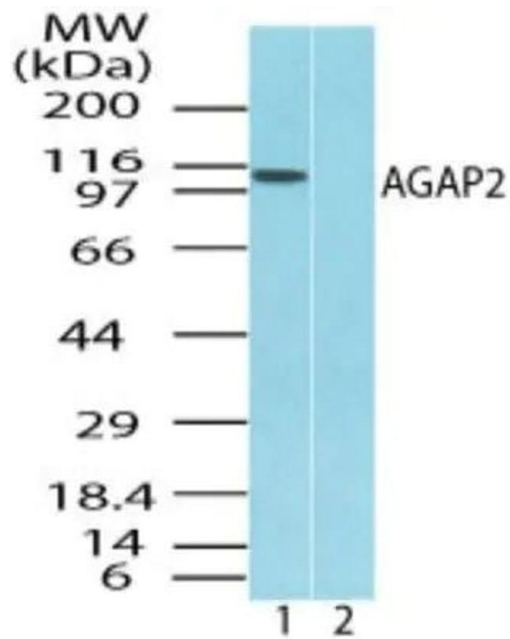

Immunohistochemical analysis of CENTG1 in formalin-fixed, paraffin-embedded human brain tissue. Samples were incubated in CENTG1 polyclonal antibody (Product # PA5-23322) using a dilution of 5 µg/mL. Isotype control (top left) and this antibody (bottom left, right).

Western blot analysis of CENTG1 in Jurkat cell lysate in the 1) absence and 2) presence of immunizing peptide using this antibody. Samples were incubated in CENTG1 polyclonal antibody (Product # PA5-23322) followed by a goat anti-rabbit Ig HRP secondary antibody. PicoTect ECL substrate solution was used for this test.
