



Western blot analysis of HMGB3 in mouse placenta lysate in the 1) absence and 2) presence of immunizing peptide. Samples were incubated in HMGB3 polyclonal antibody (Product # PA5-23362) using a dilution of 0.5  $\mu$ g/mL followed by a goat anti-rabbit Ig HRP secondary antibody. PicoTect ECL substrate solution was used for this test.
