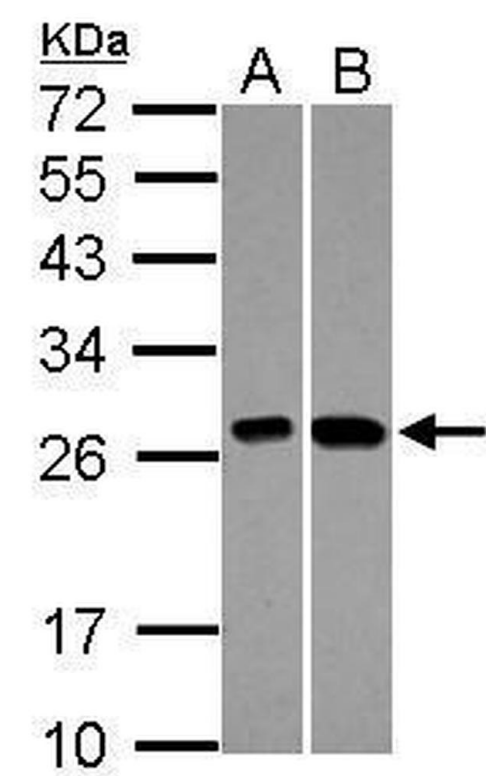

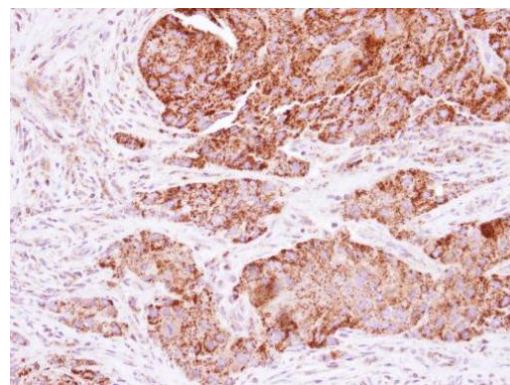
Recommended positive controls: A549, HeLa, HepG2, HCT116.
