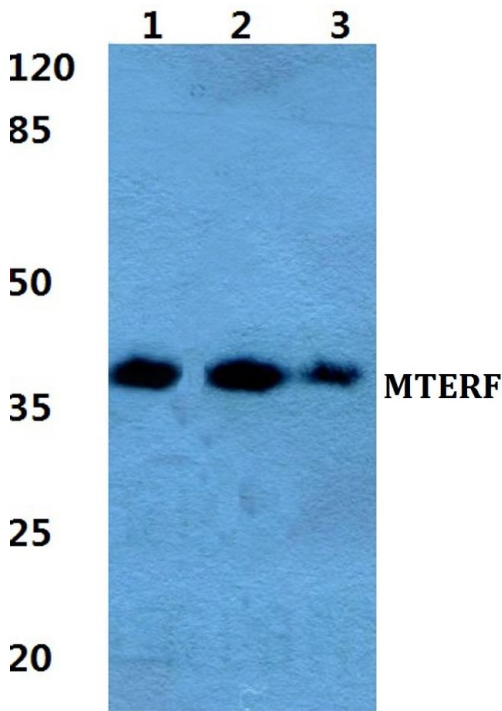

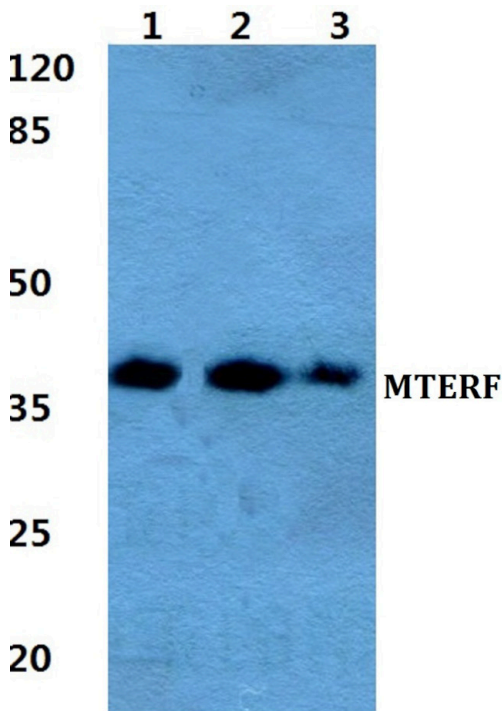
This antibody detects endogenous protein at a molecular weight of 39 and 45 kDa.
