Immunohistochemical analysis of SEZ6L2 in immersion fixed frozen sections of mouse embryo (15 d.p.c.). Samples were incubated in SEZ6L2 polyclonal antibody (Product # PA5-47669) using a dilution of 1.7 µg/mL overnight at 4 °C. Tissue was stained using the Anti-Sheep HRP-DAB Cell & Tissue Staining Kit (brown) and counterstained with hematoxylin (blue). Specific staining was localized to developing brain (medulla oblongata), spinal cord, trigeminal ganglia, and retina.
