


TAF15 Antibody (PA5-62543) in IHC

Immunohistochemical staining of TAF15 in human testis and pancreas tissues using TAF15 Polyclonal Antibody (Product # PA5-62543). Corresponding TAF15 RNA-seq data are presented for the same tissues.




TAF15 Antibody (PA5-62543)

Relative expression in different tissues in IHC: Detection of differential expression levels of TAF15 demonstrates antibody specificity. Immunohistochemical analysis of TAF15 using anti-TAF15 Polyclonal Antibody (Product # PA5-62543), shows significant staining of TAF15 in human testis and shows minimal or weak staining in human pancreas tissues. The relative expression levels of TAF15 within each tissue is shown using RNA-Seq. {RE}
