



Immunohistochemical analysis of C20orf85 using anti-C20orf85 Polyclonal Antibody (Product # PA5-63544), shows significant staining of C20orf85 in human fallopian tube and shows minimal or weak staining in human placenta tissues. The relative expression levels of C20orf85 within each tissue is shown using RNA-Seq. {RE}
