




## Phospho-EGFR (Tyr1173) Antibody (PA5-85796) in ICC/IF

Immunocytochemistry analysis of Phospho-EGFR (Tyr1173) in 4% paraformaldehyde-fixed A431 cells using Phospho-EGFR (Tyr1173) polyclonal antibody (Product # PA5-85796) at a dilution of 1:500. Sample was then incubated with Hoechst secondary antibody.

Western blot analysis of Phospho-EGFR (Tyr1173) in untreated (–) and treated (+) A431 whole cell extract using Phospho-EGFR (Tyr1173) polyclonal antibody (Product # PA5-85796) using 30 µg of sample at a dilution of 1:2000. Sample was then incubated with HRP-conjugated anti-rabbit IgG secondary antibody. Prior to incubation with primary antibody, the sample was separated on 7.5% SDS-PAGE.
