




Cytokeratin 19 Antibody (PA5-95304) in WB

Western blot analysis of Cytokeratin 19 in, Lane 1: human placenta tissue lysates. Lane 2: human MCF-7 whole cell lysates, Lane 3: human SW620 whole cell lysates, Lane 4: human HepG2 whole cell lysates, Lane 5: human PANC-1 whole cell lysates, Lane 6: rat lung tissue lysates, Lane 7: rat small intestine tissue lysates, Lane 8: mouse lung tissue lysates, Lane 9: mouse HEPA1-6 whole cell lysates. Electrophoresis was performed on a 5-20% SDS-PAGE gel at 70V (Stacking gel) / 90V (Resolving gel) for 2-3 hours. The sample well of each lane was loaded with 30 µg of sample under reducing conditions. After Electrophoresis, proteins were transferred to a nitrocellulose membrane at 150 mA for 50-90 minutes. The membrane was blocked with 5% non-fat milk/TBS for 1.5 hour at RT. The membrane was incubated with Cytokeratin 19 Polyclonal Antibody (Product # PA5-95304) at 0.5 g/mL overnight at 4°C, then washed with TBS-0. 1% Tween 3 times with 5 minutes each and probed with a goat anti-rabbit IgG-HRP secondary antibody at a dilution of 1:5,000 for 1.5 hour at RT. The signal is developed using an Enhanced Chemiluminescent detection (ECL) kit. A specific band was detected for Cytokeratin 19 at approximately 44 kDa. The expected band size for Cytokeratin 19 is at 44 kDa.



Cytokeratin 19 Antibody (PA5-95304) in ICC/IF

Immunocytochemistry analysis of Cytokeratin 19 using anti-Cytokeratin 19 antibody (Product # PA5-95304). Cytokeratin 19 was detected in a section of MCF-7 cells. Enzyme antigen retrieval was performed using IHC enzyme antigen retrieval reagent for 15 mins. The cells were blocked with 10% goat serum and then incubated with 2g/mL rabbit anti-Cytokeratin 19 antibody (Product # PA5-95304) overnight at 4°C. DyLight®488 Conjugated Goat Anti-Rabbit IgG was used as secondary antibody at 1:100 dilution and incubated for 30 minutes at 37° C. The section was counterstained with DAPI. Visualize using a fluorescence microscope and filter sets appropriate for the label used.



Cytokeratin 19 Antibody (PA5-95304) in IHC (P)

Immunohistochemical analysis of Cytokeratin 19 in a paraffin-embedded section of human colon cancer tissue. Heat mediated antigen retrieval was performed in EDTA buffer (pH 8.0, epitope retrieval solution). The tissue section was blocked with 10% goat serum. The tissue section was then incubated with 5 g/mL rabbit anti-Cytokeratin 19 antibody (Product # PA5-95304) at 4°C. Biotin conjugated goat anti-rabbit IgG was used as secondary antibody and incubated for 30 minutes at 37°C. The tissue section was developed using DyLight®488 Conjugated Avidin. The section was counterstained with DAPI. Visualize using a fluorescence microscope and filter sets appropriate for the label used.
