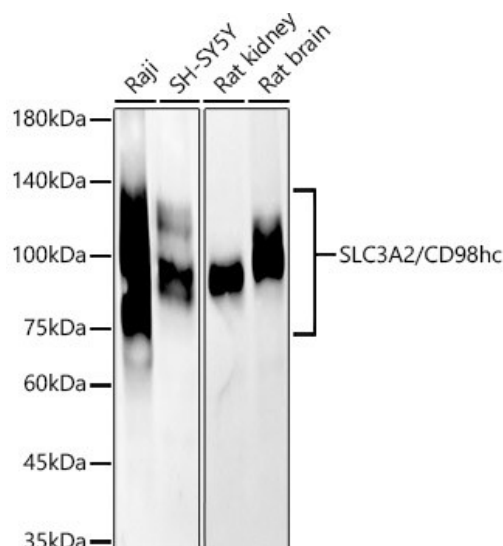

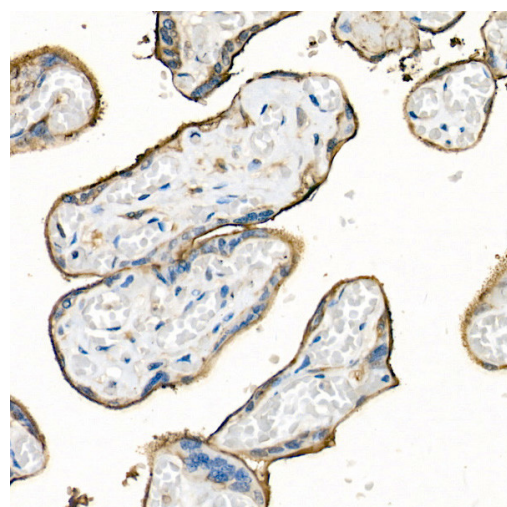

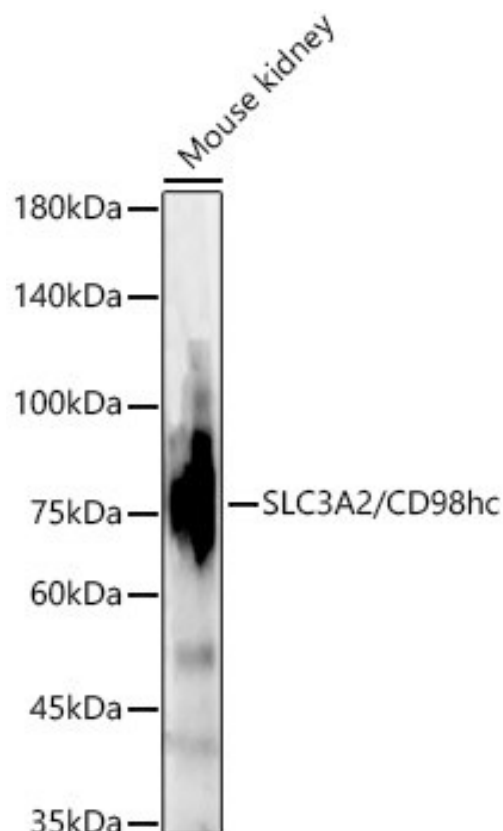
CD98 Antibody (PA5-96401) in WB

Western blot analysis of CD98 in various lysates. Samples were incubated with CD98 Polyclonal antibody (Product # PA5-96401) using a dilution of 1:1,000, followed by HRP Goat Anti-Rabbit IgG (H+L) at a dilution of 1:10,000. Lysates /proteins: 25 µg per lane. Blocking buffer: 3% nonfat dry milk in TBST. Detection: ECL Basic Kit. Exposure time: 60s.



CD98 Antibody (PA5-96401) in IHC (P)

Immunohistochemistry analysis of CD98 in paraffin-embedded human placenta. Samples were incubated with CD98 Polyclonal antibody (Product # PA5-96401) using a dilution of 1:50 (40x lens). Perform high pressure antigen retrieval with 10 mM citrate buffer pH 6.0 before commencing with IHC staining protocol.
